Violation #54. Garbage & refuse disposal

-Observed missing drain plug in dumpster and recycle bin located in front of cycle fence. Provide drain plug to prevent leaking and contamination.

CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.

Violation #56. Ventilation & lighting

-Observed light bulb burned-out inside of refrigerator located next to handwashing sink and inside of freezer located in room #004E. Replace light bulb to provide lightning.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
